# **Loan agreement between the Arrow Equestrian Club, (the borrower) and its members (the user) and the Owner of the Horse(s)**

## **Loan**

1. The Owner agrees to lend the Horse [and Tack] to the Borrower and the Borrower agrees to Borrow the Horse [and Tack] for the Term free of any rent .

## **Accommodation**

2. The Borrower [and the Users] will keep the Horse at *Weston House Farm* where they will be stabled and pastured as appropriate according to the seasons and weather. The Borrower [and the Users] will not move it to any other place without the Owner's written permission.

## **Care and attention**

3. The Borrower [and the Users] will take good care of the Horse giving it plenty of love and attention and ensure that it is cared for in accordance with its nature and worked according to "Classical" principles of horsemanship.
4. The Borrower [and Users] will use the Horse only for supervised riding including lessons and will not lend it to any other person or allow any other person to ride it or to hack it without the Owner's permission.
5. The Borrower [and the Users] may not take the horse to competitions or clinics without the owners permission.

## **Insurance**

6. The Users will undertake to ride entirely at their own risk and are responsible for their own insurance against all usual risks including death or injury and third party risks.

## **Tack etc.**

10. The owner will provide for the Horse properly and whenever necessary all appropriate tack, rugs and other equipment.
11. The Borrowers [and the Users] will keep the Tack in a good and well maintained condition, and report any damage, loss or need of repair to the owner. No tack or equipment may be used for any purpose except on or for the Horse.

## **Warranty**

12. The Owner owns the Horse free from encumbrances but otherwise gives no warranty of any kind about it and the Borrower must rely for all purposes exclusively on his [or her] [or the Users'] judgement and refer any issues relating to the health, welfare and behaviour of the horse to the owner.

## **Owner's access**

13. The Borrower [and the Users] will allow the owner unlimited access to the horse.

## **Not to operate or destroy**

14. Except in the case of emergency the Borrower will not have the Horse operated on without consultation with the Owner or destroyed without the Owner's written consent.

## **Termination**

15. The Borrower may terminate the borrowing at any time in the first four weeks of the Term without any penalty or liability to the Owner.
16. The Owner may terminate the Loan and re-take possession of the Horse [and Tack] at any time .
17. The Owner may terminate the Loan and re-take possession of the Horse [and tack] if the Borrower [or the Users ] fails to comply with the terms of this agreement or if the Owner has good reason to believe that she should do so in the interest of the health or welfare of the Horse.

## **Effect of termination**

18. The Owner has the right to request the immediate expulsion from the Arrow Equestrian Club of any person she/he believes fails to comply with the terms of this agreement.

## **Disputes**

19 All disputes differences and questions which at any time arise between the parties touching or arising out of or in respect of this agreement or its subject matter which cannot be resolved in a Special Meeting shall result in termination of the Loan and the Owner shall re-take possession of the Horse.
